What a year of growth and hope we've provided for deserving families served by Bryan's House. As an agency we've demonstrated strength in our ability to pivot with excellence to meet and exceed our clients' needs.

Together with your support, we met our financial goals and we are thriving in crisis to stay the course.

We innovated with health and safety protocols as our main priority, to deliver solutions successfully in eight counties to catch those about to fall into homelessness and generational poverty - especially those with one or more children with special health, education and domestic needs. All this, in the shadow of a deadly pandemic.

We expanded our mission and inclusive initiatives even further, utilizing the experience and knowledge of our culturally diverse team members, volunteers, medical and clinical teams and our dedicated Board of Directors. Most importantly we are reaching and serving those individuals and families who've been ignored, discriminated against, or forgotten.

Our Case Managers provided 7,100 hours of crisis intervention, and worked tirelessly for families impacted by COVID-19 during those first months from April to June. A two-page special COVID update is included in this report.

For every dollar spent at Bryan's House, we save nine dollars in the community to deliver our mission. We save tax payers thousands more each year as we graduate our families out of our programs, armed with budget tools and financial plans. They convert those new skills into jobs that pay livable wages, sustaining their family's success and their children's ability to thrive for unknown times to come.

We are sincerely grateful to all of you who donated, partnered or supported our agency. We appreciate our 2020 Luncheon sponsors and ticket holders who agreed to donate back those funds this year, so we could utilize them immediately for programs that impacted 200 families.

We included success stories in this report which reflect the tenacity, courage and strength of the children, parents and our staff. They never gave up and neither did we.

Everyone loves Bryan's House. Our authentic culture of excellence means that we can solve complex challenges responsibly, with love and laughter in our hearts to tackle those unknown times ahead. 





COVID RESPONSE

Bryan's House is providing robust COVID-19 crisis intervention and triage for crisis-caught families with one or more children at home with special needs. We are assisting families with emergency funding, mental health support services, and helping connect families to vital services.

From March 2020 through November 2020, we provided **\$149,755** in Emergency Financial Assistance (EFA) to **239** duplicated families, and our Case Managers provided **7,540** hours of service for crisis intervention.









OUR MISSION

To provide underserved children in North Texas with specialized medical, educational and therapeutic care, and holistic support services to thrive.

WE ACCOMPLISH OUR MISSION THROUGH TWO UMBRELLA PROGRAMS:

ONSITE

Integrates on-site nursing with high-quality education, therapy, and developmental care geared to each child's needs. Each program serves the same populations, except therapy. We serve medically and developmentally atypical children alongside their typically developing peers and siblings.

EARLY CHILDHOOD EDUCATION PROGRAM

- Serves medically at-risk children ages 0-5.
- Open Monday-Friday 7 am - 6 pm.
- Accredited by the National Association for the Education of Young Children (NAEYC)

RESPIRE CARE

- Serves special needs children ages 0-13.
- Provides relief for parents & caregivers.
- Offered two Saturdays a month.

AFTER-SCHOOL, SUMMER AND HOLIDAY PROGRAM

- Serves medically at-risk children ages 0-13.
- Provides learning, developmental, and recreational activities according to ability.

COLLABORATIVE THERAPY

- Is a therapeutic bridge between classroom & home.
- Utilizes assessment outcomes to create a holistic treatment plan.
- Therapy Coordination



OFFSITE

Provides individualized strategic intervention and planning up to age 21 designed to promote increased knowledge, skills and behaviors that will enable families with special-needs children to manage emergencies, sustain basic needs, achieve their goals and expand their opportunities for long-term success.

- Case Management/Navigation in the home
- Basic Needs Services (Food, clothing, shelter)
- Referrals to Community Services
- Crisis Intervention

BECAUSE WE INTERVENED EARLY...

100% of families (whose goal was to advance their education) furthered their education.

100% of families found a “medical home” for their children.

99% of families established permanent homes.

91% of families accomplished at least 80% of their self-sufficient goals.

96% of families graduated our care with a job and steady income.

91% of families stabilized their domestic situation and are thriving.

100% of families received medical devices needed to provide mobility in the home, vehicle or classroom.

92% of families learned how to create and manage a home budget.

92% of families learned how to save with Case Manager guidance.

98% of families learned to plan and shop wisely.

100% of families were accompanied (in person and remotely) by staff to advocate for medical, legal, employment or other services.


ALEJANDRA

Alejandra is a 10 year old girl diagnosed with Acute Leukemia. Her family recently graduated from our Social Services Program, as all their program plan goals were met.

Alejandra is doing exceptionally well after 6 months of professional and nurturing care. Our doors remain open to Alejandra and her family in the event that continued services are needed.

Her Case Manager Sofia provided constant care, and was their "life line".

WHAT WE DO WELL



SUCCESS STORY: ERIKA, “SUPER MOM”



The year 2020 has been a rollercoaster ride for Erika's family of five. Erika's husband is chronically ill and unable to work. Erika's youngest daughter was diagnosed with Epilepsy, Autism and ADHD. Erika is the family's breadwinner, and she lost her job due to multiple absences to address her family's complex medical issues. The loss of income quickly led to homelessness. The family slept in their car until they were referred to Bryan's House for Family Supportive Services. We provided emergency financial assistance to help the family remain stable in temporary housing. Within several weeks of working

with the family, providing resources, financial coaching and care coordination, Erika obtained health insurance for her husband and children. Our Case Managers connected her husband to specialty care resources and coordinated therapeutic services for her daughter. Erika started working delivering food, a job that provided her a flexible schedule to manage the care for her family. She worked on budgeting to save money so the family could move into their own apartment.

Then the COVID-19 pandemic hit. With so many people out of work due to the shutdown, workers glutted the food delivery job market and Erika could no longer

make enough money to provide for her family's basic needs. The family's journey to stability was again jeopardized and she needed additional support.

Our Case Managers advocated their plight to a private funder for long term financial assistance and planning. The family was awarded a grant for 12 months which included medical equipment and rent so they could get back on their feet. After many months of struggles, the family has moved into a rental house. Erika and her family are managing a budget and transitioning to permanent employment which will raise them out of poverty moving forward.




